For those with multiple dogs, exhibitors may handle only one dog per element level per trial. *For example, you may run one dog in novice Containers, and another in advance Containers, but the same handler cannot run 2 dogs in novice. Entries will be returned with 2 or more dogs entered in the same class.*
